TO 2009 SENATE BILL 40

At the locations indicated, amend the bill as follows:

1. Page 17, line 15: delete the material beginning with "disbursements" and ending with "office" on line 16 and substitute "disbursement amount made or obligated to be made, but not to exceed, in the aggregate, exclusive of any amount to which the candidate is entitled under s. 11.513 (2), an amount equal to 3 times the public financing benefit payable to a candidate for the applicable office at the primary or other election for which the benefit is received".
