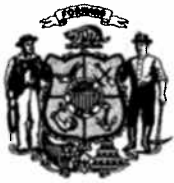

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 18, line 5: after “disbursements” insert “made or obligated to be made
- 3 by a person”.
- 4 **2.** Page 18, line 7: delete “any campaign” and substitute “the primary election
- 5 campaign period or the election campaign period”.
- 6 **3.** Page 18, line 9: after “to be made” insert “by a person”.
- 7 **4.** Page 18, line 10: delete that line and substitute “, exclusive of any amount
- 8 to which a candidate is entitled under s. 11.512 (2), an amount equal to 3 times the
- 9 public financing benefit payable to a candidate for the applicable office at the
- 10 primary or other election for which the benefit is received”.
