# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION** 119.16 (11) of the statutes is created to read:

119.16 (11) RESIDENCY REQUIREMENTS. (a) In this subsection, "teacher" means any person holding a license or permit issued by the state superintendent whose employment by a school district requires that he or she hold that license or permit.

(b) The board may not require, as a condition of employment, that a teacher reside within the district.
