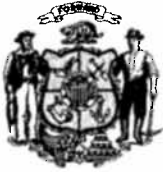

3 "SECTION 1c. 125.07 (1) (a) 1. of the statutes is amended to read: ✓

4 125.07 (1) (a) 1. No person may procure for, sell, dispense, or give away any  
5 alcohol beverages to any underage person ~~not~~ unless the underage person is  
6 accompanied by his or her parent, guardian, or spouse who has attained the legal  
7 drinking age and, if on licensed premises, the underage person is at least 18 years  
8 of age. ✓

9 2. Page 2, line 1: delete "SECTION 1" and substitute "SECTION 1m". ✓
