


2 1. Page 4, line 3: after that line insert:

3 "SECTION 3m. 26.97 (1) of the statutes is amended to read:

4 26.97 (1) Arrest a person, with or without a warrant, when the person is
5 detected actually committing a violation of this chapter, subch. VI of ch. 77, or s.
6 167.10 (3), 287.81 (4), 941.10 (1), 941.11, 941.12, 941.13, 943.02 (1), 943.03, 943.04,
7 943.05 or 943.06 (2)."
