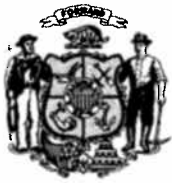

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: after "resources" insert ", term of service of members of the  
3 Natural Resources Board,".

4 **2.** Page 2, line 7: substitute "~~6-year~~ 4-year" for "6-year".

5 **3.** Page 3, line 3: after that line insert:

6 **"SECTION 4m. Initial applicability.**

7 (1) The treatment of section 15.34 (2) (a) of the statutes, as it relates to the term  
8 of a member of the natural resources board, first applies to a member of the natural  
9 resources board confirmed or reconfirmed after July 1, 2009.".
