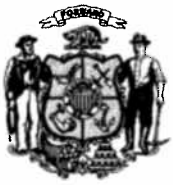

- 5 appointed and qualifies, except that the position held by the member becomes vacant
- 6 one year after the expiration of the term.”. ✓
