1 AN ACT *to amend* 15.05 (1) (c); and *to create* 15.343 (2) and 23.127 of the  
2 statutes; **relating to:** the appointment of the secretary of natural resources  
3 and the creation of a division of parks and wildlife management in the  
4 Department of Natural Resources.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

5 SECTION 1. 15.05 (1) (c) of the statutes is amended to read:  
6 15.05 (1) (c) The secretary of natural resources shall be nominated by the  
7 governor, and with the advice and consent of the senate appointed, to serve at the  
8 pleasure of the governor. The governor shall nominate an individual who has held  
9 an annual hunting, fishing, or trapping license in this state or another state in at  
10 least 4 of the 8 years previous to the year in which the individual is nominated.

11 SECTION 2. 15.343 (2) of the statutes is created to read:
