

AN ACT *to amend* 15.05 (1) (c); and *to create* 15.343 (2) and 23.127 of the statutes; **relating to:** the appointment of the secretary of natural resources and the creation of a division of parks and wildlife management in the Department of Natural Resources.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 15.05 (1) (c) of the statutes is amended to read:

15.05 **(1)** (c) The secretary of natural resources shall be nominated by the governor, and with the advice and consent of the senate appointed, to serve at the pleasure of the governor. The governor shall nominate an individual who has held an annual hunting, fishing, or trapping license in this state or another state in at least 4 of the 8 years previous to the year in which the individual is nominated.

Section 2. 15.343 (2) of the statutes is created to read:
