AN ACT to create 302.395 of the statutes; relating to: charges for inmate

telephone use at a jail or house of correction.

Analysis by the Legislative Reference Bureau

Under this bill, charges imposed for a telephone call made by a person confined in a jail or house of correction may not exceed the charges that would be imposed for a comparable telephone call made by a person confined in a state prison.

For further information see the *local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 302.395 of the statutes is created to read:

302.395 Charges for inmate telephone use. The charges imposed for a telephone call made by a person confined in a jail or house of correction may not exceed the charges that would be imposed for a comparable telephone call made by a person confined in a state prison.
