

ASSEMBLY AMENDMENT, TO 2009 ASSEMBLY BILL 176



At the locations indicated, amend the bill as follows:

1. Page 4, line 10: after "section." insert "Those rules shall include a rule requiring the department, whenever it inspects a child care provider that is licensed under s. 48.65 (1) or established or contracted for under s. 120.13 (14), and a county department, whenever it inspects a child care provider that is certified under s. 48.651, to inspect the child safety alarm of each child care vehicle that is used to transport children to and from the child care provider to determine whether the child safety alarm is in good working order.".
