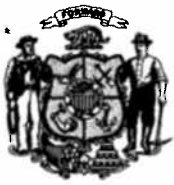

4 **"SECTION 7m.** 343.30 (1g) (b) of the statutes, as affected by 2009 Wisconsin Act  
5 102, is amended to read:"

6 **3.** Page 5, line 19: before "(b)" insert "343.30 (1g)".

11 substitute "(d) Any revocation under this paragraph subsection".
