2009 ASSEMBLY BILL 200

April 7, 2009 – Introduced by Representatives Rhoades, Mursau, Kerkman, Lothian, LeMahieu, Gottlieb, Strachota, A. Ott, Murtha, Bies, Gunderson and Townsend, cosponsored by Senators Kreitlow, Schultz and Kedzie. Referred to Committee on Education.

1	AN ACT <i>to repeal</i> 115.01 (10) (b) and 121.02 (1) (f) 1.; <i>to renumber</i> 115.01 (10)
2	(a); <i>to renumber and amend</i> 121.006 (2) (a) and 121.02 (1) (f) 2.; <i>to amend</i>

5	statutes; relating to: the number of school days required each school term.

Analysis by the Legislative Reference Bureau

Under current law, school is required to be held for at least 180 days during the school term (the time beginning with the first school day and ending with the last school day that the schools are in operation for the attendance of pupils in a school year). In addition, each school board must schedule at least 437 hours of direct pupil instruction in kindergarten, at least 1,050 hours of direct pupil instruction in grades 1 to 6, and at least 1,137 hours of direct pupil instruction in grades 7 to 12. This bill retains the requirement that school be held for these minimum required hours of instruction but eliminates the requirement that school be held for at least 180 days.

18	number of hours of direct pupil instruction provided in each school, by teachers
19	legally qualified to teach.
20	SECTION 6. 121.004 (5m) of the statutes is created to read:
21	121.004 (5m) MINIMUM REQUIRED HOURS OF INSTRUCTION. "Minimum required
22	hours of instruction" means the number of hours of direct pupil instruction required
23	for the grade in which a pupil is enrolled as specified in s. 121.02 (1) (f).
24	SECTION 7. 121.004 (7) (c) 1. b. of the statutes is amended to read:

1	121.004 (7) (c) 1. b. A pupil enrolled in a 5-year-old kindergarten program
2	requiring full–day attendance for less than 5 days a week for an entire school year
3	term shall be counted as the result obtained by multiplying the number of hours in
4	each day in which the pupil is enrolled by the total number of days for which the pupil
5	is enrolled, and dividing the result by the product of the <u>total</u> number of hours of
6	attendance per day required of first grade pupils in the school district multiplied by
7	180 .
8	SECTION 8. 121.004 (7) (cm) of the statutes is amended to read:
9	121.004 (7) (cm) A pupil enrolled in a 4-year-old kindergarten program,
10	including a 4-year-old kindergarten program being phased in under s. 118.14 (3) (b),
11	that provides the minimum required number of hours of direct pupil instruction
12	under s. 121.02 (1) (f) 2. shall be counted as 0.6 pupil if the program annually provides
13	at least 87.5 additional hours of outreach activities.
14	SECTION 9. 121.006 (2) (a) of the statutes is renumbered 121.006 (2) (a) (intro.)
15	and amended to read:
16	121.006 (2) (a) (intro.) Hold school for at least 180 days each year the minimum
17	required hours of instruction, less any days of the following:
18	<u>1. Hours</u> during which the state superintendent determines that school is not
19	held or educational standards are not maintained as the result of a strike by school
20	district employees, the days to be computed in accordance with s. 115.01 (10).
21	SECTION 10. 121.006 (2) (a) 2. of the statutes is created to read:
22	121.006 (2) (a) 2. Hours during which school is closed by order of a local health
23	officer, as defined in s. 250.01 (5).
24	SECTION 11. 121.02 (1) (f) 1. of the statutes is repealed.

1 SECTION 12. 121.02 (1) (f) 2. of the statutes is renumbered 121.02 (1) (f) and 2 amended to read:

3 121.02 (1) (f) Annually, schedule at least 437 hours of direct pupil instruction 4 in kindergarten, at least 1,050 hours of direct pupil instruction in grades 1 to 6, and 5 at least 1,137 hours of direct pupil instruction in grades 7 to 12, or the number of 6 hours of direct pupil instruction the school board scheduled during the 2009-10 7 school year, whichever is greater. Scheduled hours under this subdivision paragraph 8 include recess and time for pupils to transfer between classes but do not include the 9 lunch period. Scheduled hours under this paragraph may include no more than 35 10 hours on Saturdays. A school board operating a 4-year-old kindergarten program 11 may use up to 87.5 of the scheduled hours for outreach activities.

SECTION 13. 121.23 (2) (intro.) of the statutes is amended to read:

13 121.23 (2) (intro.) If a school district holds less than 180 days of school the 14 minimum required hours of instruction as the result of a strike by school district 15 employees, for the purposes of computing general aid, the state superintendent shall 16 compute the school district's primary and secondary ceiling costs per member in 17 accordance with the procedure specified in pars. (a) to (e). In making the calculation, 18 the state superintendent shall:
