At the locations indicated, amend the bill as follows:

1. Page 5, line 15: after that line insert:

"SECTION 11m. 29.563 (2) (intro.) of the statutes is amended to read:

29.563 (2) HUNTING APPROVALS. (intro.) Except as provided in sub. (2m) and (2r),
the fees for hunting approvals are as follows:".

2. Page 6, line 4: after that line insert:

"SECTION 15m. 29.563 (2r) of the statutes is created to read:

29.563 (2r) HUNTING APPROVALS FOR 10 AND 11 YEAR OLDS. The fee for a hunting
approval listed under sub. (2) issued to a person who is 10 or 11 years of age is \$4.25.".
