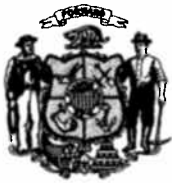

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 4, line 5: delete lines 5 to 7 and substitute:
- 3 "943.50 (4m) Whoever violates sub. (1m) (a), (b), (c), (d), (e), or (f) is guilty of
- 4 a Class I felony if all of the following apply:
- 5 (a) The value of the merchandise does not exceed \$1,500.
- 6 (b) The person agrees or combines with another to commit the violation.
- 7 (c) The person intends to sell the merchandise by means of the Internet."
