

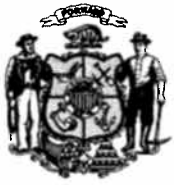

3 “SECTION 65m. 101.123 (3) (L) of the statutes is created to read:

4 101.123 (3) (L) An enclosed area with a separate ventilation system that is
5 located in a place of employment and that is designated by the person in charge as
6 an area in which smoking is allowed.”

2 **1.** Page 13, line 24: after that line insert:

3 "SECTION 65g. 101.123 (3) (jL) of the statutes is created to read:

4 101.123 (3) (jL) An enclosed place in a nursing home, ^aWisconsin veterans home,
5 or an assisted living facility that has been designated as an area where smoking is
6 allowed, as provided in sub. (3d)."

7 **2.** Page 14, line 5: after that line insert:

8 "SECTION 66m. 101.123 (3) ^d of the statutes is created to read:

9 101.123 (3d) NURSING HOMES, VETERANS HOMES, AND ASSISTED LIVING FACILITIES.

10 A nursing home, as defined in s. 50.01 (3), a Wisconsin veterans home under s. 45.50,
11 or an assisted living facility may designate an enclosed place in the nursing home,

1 Wisconsin veterans home, or assisted living facility that has a separate ventilation
2 system as an area ^eis in which smoking is allowed.”.
