Rep. Lothian would like an amendment drafted to Assembly Bill 282, which is scheduled for action tomorrow.

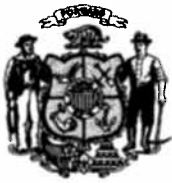
The amendmend would simply remove Walworth County from the list of counties affected by this legislation.
