

"Section 60m. 77.70 (2) of the statutes is created to read:

77.70 (2) In addition to the taxes imposed under sub. (1), if the tax imposition is approved by the electors in the county at a referendum, Milwaukee County may adopt an ordinance to impose a sales and use tax under this subchapter at the rate of no more than 0.5 percent of the sales price or purchase price to be used for transit purposes. The taxes may be imposed only in their entirety. If Milwaukee County imposes the taxes under this subsection, it shall not levy property taxes to pay for transit. An ordinance adopted under this subsection shall be effective on January 1, April 1, July 1, or October 1. A certified copy of the ordinance shall be delivered to the secretary of revenue at least 120 days prior to its effective date. The repeal ordinance shall be delivered to the secretary of revenue at least 120 days before the effective date of the repeal.".
