9 transportation, sentencing by a court, or revocation or suspension of motor vehicle
10 operating privileges.

11 **SECTION 85. Effective dates.** This act takes effect on first day of the 3rd
12 month beginning after publication, except as follows:

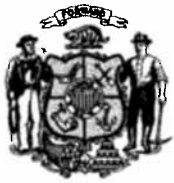

21 347.413 (title) and (1), 347.417 (1), 347.417 (2), and 347.50 (1s) of the statutes, the
