ASSEMBLY AMENDMENT ,
TO ASSEMBLY SUBSTITUTE AMENDMENT (LRBs0113/4),
TO 2009 ASSEMBLY BILL 283 ASA1

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 30, line 10: delete "This" and substitute "Except as provided in par.
3 (am), this".

4 **2.** Page 30, line 14: after that line insert:

5 **"SECTION 76m.** 969.01 (2) (am) of the statutes is created to read:

6 969.01 (2) (am) If the number of a person's convictions under ss. 940.09 (1) and
7 940.25 in the person's lifetime, plus the total number of suspensions, revocations,
8 and other convictions counted under s. 343.307 (1) equals 3, the trial court may, in
9 its discretion, release the person pursuant to s. 969.02 for the purpose of receiving
10 treatment or counseling for alcohol or drug abuse if a licensed driver assumes
11 responsibility for transporting the person from prison or jail to the treatment or

1 counseling facility and returning the person to prison or jail after the person receives
2 treatment or counseling.”.
