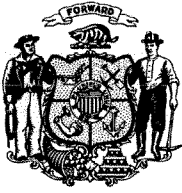

- 1 AN ACT *to create* 70.11 (45) of the statutes; **relating to:** a real property tax
2 exemption for snowmobile clubs.

Analysis by the Legislative Reference Bureau

This bill provides a property tax exemption for the real property of a snowmobile club that is a nonprofit organization.

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill.

For further information see the ***state and local*** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 3 SECTION 1. 70.11 (45) of the statutes is created to read:
4 70.11 (45) SNOWMOBILE CLUBS. Real property of a snowmobile club that is
5 exempt from taxation under section 501 (c) (3) of the Internal Revenue Code.
6 SECTION 2. **Initial applicability.**
