

AN ACT to create 70.11 (45) of the statutes; relating to: a personal property tax

exemption for snowmobile clubs.

Analysis by the Legislative Reference Bureau

This bill provides a property tax exemption for the personal property of a snowmobile club that is a nonprofit organization.

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 3 **Section 1.** 70.11 (45) of the statutes is created to read:
- 4 70.11 (45) SNOWMOBILE CLUBS. Personal property of a snowmobile club that is
- 5 exempt from taxation under section 501 (c) (3) of the Internal Revenue Code.
- 6 Section 2. Initial applicability.
