AN ACT *to create* 70.11 (45) of the statutes; **relating to:** a property tax exemption

for snowmobile and all-terrain vehicle clubs.

Analysis by the Legislative Reference Bureau

This substitute amendment provides a property tax exemption for <u>snowmobile</u> trail groomers owned by a snowmobile club or an all–terrain vehicle club that is a nonprofit organization.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 70.11 (45) of the statutes is created to read:

70.11 **(45)** Snowmobile and all-terrain vehicle club that is exempt

from taxation under section 501 (c) (3), (4), or (7) of the Internal Revenue Code.

SECTION 2. Initial applicability.
