Assumptions Used in Arriving at Fiscal Estimate

PROVISIONS OF THE BILL

This bill creates a new special license plate available to "persons interested in expressing their support for the family members of law enforcement officers who have died in the line of duty."

The special plate would be available to anyone; there is no eligibility or limitation on who may obtain the plate. The plate is not a fund-raising plate.

The plate would be subject to the \$15 issuance or reissuance fee, as are other special plates. Issuance and reissuance fee revenue would be deposited in the Transportation Fund.

The bill has a delayed effective date of four months (effective first day of the 5th month after publication).

FISCAL EFFECT

One-time fiscal impact:

DMV would incur a one-time cost of \$11,800 to create this new non-fund-raising special plate. The bill does not fund this cost, and DMV cannot absorb this cost within its current budget.

The one-time cost includes \$11,100 for data processing modifications. Changes must be made to DMV's processing, plate ordering, renewal, and printing modules. There is also \$700 cost for graphic design of the special plate logo.

Annual on-going fiscal impact:

Each set of special plates issued would incur a \$15 issuance or reissuance fee, which is deposited in the Transportation Fund. The fee offsets the cost to DMV of issuing the special plate, although DMV's appropriation is not increased under the bill. Based on sales of other special plates, it is anticipated that few special plates would be sold each year, and DMV could absorb the workload.
