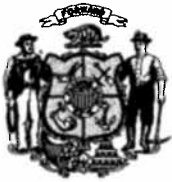

 12 fiscal year of the fiscal biennium in which this subsection[✓] takes effect to increase
 13 funding for special registration plates for persons interested in expressing their
 14 support for the family members of law enforcement officers who have died in the line
 15 of duty.”[✓]
