5 "operator" on line 8.

6 3. Page 2, line 11: delete "telephone" and substitute "telephone,".

7 4. Page 2, line 12: delete "that is not" and substitute "to transmit or receive
8 data unless the cellular telephone or other wireless telecommunications device is".
