AN ACT  $\frac{1}{4}$ ; relating to: an exemption from recording for time-share licenses.

### Analysis by the Legislative Reference Bureau

Current law provides that a contract or other instrument evidencing the purchase of a time share is not valid unless it is recorded. This bill provides that this requirement does not apply to a contract or other instrument evidencing the purchase of a time-share license, which is a right to occupy a time-share unit under a license or lease agreement.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **Section 1.** 707.46 (3) of the statutes is renumbered 707.46 (3) (a).
- 3 SECTION 2. 707.46 (3) (b) of the statutes is created to read:
- (4) 707.46 (3) (b) Paragraph (a) does not apply to a contract or other instrument evidencing the purchase of a time-share license.
