Please draft an amendment to SB 299 for Sen. Jauch and to AB 428 for Rep. Grigsby to require DCF to transmit the summary reports to the governor and appropriate standing committees and to require the standing committees to review the reports, conduct public hearings annually, and submit recommendations to DCF (same language as you drafted for the quarterly sexual abuse reports under the bill). Second, add incidents where employees and contractors of an agency sexually assault a child to the quarterly sexual assault reports.

At the locations indicated, amend the bill as follows:

**1.** Page 8, line 23: delete "prepare and" and substitute "prepare, transmit to the governor and to the appropriate standing committees of the legislature under s. 13.172 (3), and".

**2.** Page 9, line 5: delete "prepare and" and substitute "prepare, transmit to the governor and to the appropriate standing committees of the legislature under s. 13.172 (3), and".

**3.** Page 9, line 7: after "2." insert "Those committees shall review all summary reports and reports of changes and recommended changes transmitted under this subd. 3. b., conduct public hearings on those reports no less often than annually, and submit recommendations to the department regarding those reports."

**4.** Page 9, line 9: delete lines 9 to 14 and substitute "prepares the summary report from releasing to the governor, to the appropriate standing committees of the

1 legislature under s. 13.172 (3), or to the public any of the information specified in  
 2 subd. 4. or 5. before the summary report is transmitted to the governor and to those  
 3 committees and made available ~~to~~ <sup>to</sup> the public; adding to or amending a summary  
 4 report if new information specified in subd. 4. or 5. is received after the summary  
 5 report is transmitted to the governor and to those committees and made available  
 6 to the public; or releasing to the governor, to those committees, and to the public any  
 7 information at any time to correct any inaccurate information reported in the news  
 8 media.”.

9 **5.** Page 12, line 14: delete lines 14 to 16 and substitute “transmits, releases,  
 10 or discloses information under subd. 3. may not transmit the summary report to the  
 11 governor and to the appropriate standing committees of the legislature under s.  
 12 13.172 (3), make the summary report available to the public, or transmit, release, or  
 13 disclose the information to the governor, to those standing committees, or to the  
 14 public if the subunit determines that transmitting or making the summary report  
 15 available or transmitting, releasing, or disclosing the information would jeopardize  
 16 any of the following:”.

17 **6.** Page 12, line 22: after “disclose” insert “to the governor, to the appropriate  
 18 standing committees of the legislature under s. 13.172 (3), or”.

19 **7.** Page 13, line 10: delete “releasing” and substitute “transmitting,  
 20 releasing.”.

21 **8.** Page 13, line 14: delete “releasing” and substitute “transmitting,  
 22 releasing.”.

23 **9.** Page 14, line 6: ~~after~~ “relative,” ~~insert~~ <sup>delete</sup> “by any employee or contractor of the  
 24 agency supervising the child’s placement”.
