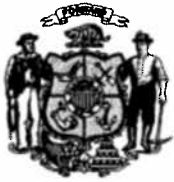

Section 36. 448.72 (8) of the statutes is created to read:

448.72 (8) A retailer, including a seller as defined by sec. 108.02 (15)(k)(16), that sells food, food materials, dietary supplements, and other goods and that furnishes oral or written general nonmedical nutrition information related to the sale, marketing and distribution of the food, food materials, dietary supplements or other goods.

S. 108.02 (15)(k)16. does not define "retailer," but defines an exemption from "employment" in the Chapter governing Unemployment Insurance and Reserves. as applied to work for a given employer other than a joint vent or nonprofit organizations

3 an individual whose remuneration consists solely of commissions, overrides,
4 bonuses, or differentials directly related to sales or other output derived from
5 in-person sales to or solicitation of orders from ultimate consumers, primarily in the
6 home."
