After speaking with Rep. Kestell, he requested two amendments to address the ways we talked about making the public/private damage recovery action in the bill equal:

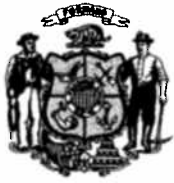
1. Cap all damages against any person at the \$250,000 state level

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 18: after that line insert:

3 "SECTION 4m. 893.587 (4) of the statutes is created to read:

4 893.587 (4) Except as provided in ~~§s.~~ 893.80, the amount recoverable by any  
5 person in a civil action under this section for any damages or injuries may not exceed  
6 \$250,000."
