- 4 Act 28, is repealed.
- 5 SECTION 361. 49.155 (3m) (e) 2. of the statutes, as created by 2009 Wisconsin
- 6 Act 28, is renumbered 49.155 (3m) (e) and amended to read:
- 7 49.155 (3m) (e) No funds distributed under par. (a) may be used for child care
- 8 services that are provided for a child by a child care provider who employs either the
- 9 parent of the child or a person who resides with the child, unless the child care
- 10 provider is licensed under s. 48.65 and at all times at least 60 percent of the children
- 11 for whom the child care provider is providing care are qualifying children.
