



**ASSEMBLY AMENDMENT 2,
TO 2009 ASSEMBLY BILL 486**

October 27, 2009 – Offered by Representative DEXTER.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 15: delete “and”.

3 **2.** Page 3, line 18: after “placement” insert “; and changing the effective date
4 for paying to certain former public assistance recipients support or maintenance
5 arrears collected by the state”.

6 **3.** Page 48, line 18: delete “By no later than 90 days” and substitute “During
7 the 90 days immediately”.

8 **4.** Page 48, line 24: delete “by no later than 90 days” and substitute “during
9 the 90 days immediately”.

10 **5.** Page 49, line 9: delete “By no later than 90 days” and substitute “During the
11 90 days immediately”.

1 **6.** Page 49, line 15: delete “by no later than 90 days” and substitute “during
2 the 90 days immediately”.

3 **7.** Page 97, line 7: after that line insert:

4 “**SECTION 178r.** 2009 Wisconsin Act 28, section 9308 (9) is amended to read:

5 [2009 Wisconsin Act 28] Section 9308 (9) ARREARAGES COLLECTED. The
6 treatment of section 49.1452 of the statutes first applies to arrearages collected on
7 ~~the effective date of this subsection~~ January 1, 2010.

8 **SECTION 178t.** 2009 Wisconsin Act 28, section 9322 (7) (a) is amended to read:

9 [2009 Wisconsin Act 28] Section 9322 (7) (a) *Arrearages collected.* The
10 treatment of section 49.776 of the statutes first applies to arrearages collected on the
11 ~~effective date of this paragraph~~ January 1, 2010.

12 **SECTION 178w.** 2009 Wisconsin Act 28, section 9408 (14) is amended to read:

13 [2009 Wisconsin Act 28] Section 9408 (14) ARREARAGES COLLECTED. The
14 treatment of section 49.1452 of the statutes and SECTION 9308 (9) of this act take
15 effect on January April 1, 2010.

16 **SECTION 178x.** 2009 Wisconsin Act 28, section 9422 (12) (a) is amended to read:

17 [2009 Wisconsin Act 28] Section 9422 (12) (a) *Arrearages collected.* The
18 treatment of section 49.776 of the statutes and SECTION 9322 (7) (a) of this act take
19 effect on January April 1, 2010.”.

20 **8.** Page 99, line 12: after “publication,” insert “whichever is later,”.

21 **9.** Page 99, line 23: after that line insert:

22 “(2) SUPPORT ARREARS PASS-THROUGH. SECTIONS 178r, 178t, 178w, and 178x of
23 this act take effect on the day after publication.”.
