Additionally, we want to narrow the definition so that it applies to 'qualifying relationships,' such as familial or intimate relationships, not to roommate situations.

2 **1.** Page 5, line 20[✓]: delete “has the meaning given in s. 813.12 (1) (ag)” and
3 substitute “means a romantic or intimate social relationship between 2 individuals
4 but “dating relationship” does not include a casual relationship or an ordinary
5 fraternization between 2 individuals in a business or social context. A court shall
6 determine if a dating relationship existed by considering the length of the
7 relationship, the type of the relationship, and the frequency of the interaction
8 between the individuals involved in the relationship.”[✓]

9 **2.** Page 5, line 22: delete that line.

10 **3.** Page 5, line 25: delete the material beginning with “or adult” and ending
11 with “household member” on page 6, line 1.[✓]

12 **4.** Page 6, line 1: delete the material beginning with “adult family” and ending
13 with “member” on line 2 and substitute “family member”[✓].

- 1 **5.** Page 6, line 2: delete “against an adult” and substitute “against a person”.
- 2 **6.** Page 6, line 3: delete “adult former” and substitute “former”.
- 3 **7.** Page 6, line 3: delete “against an adult” and substitute “against a person”.
- 4 **8.** Page 6, line 4: delete “the person” and substitute “the adult”.
- 5 **9.** Page 6, line 4: delete “against an adult” and substitute “against a person”.
- 6 **10.** Page 6, line 5: delete “person” and substitute “adult”.

8 ending with “whom the person” on line 10 and substitute “adult actor engaged in

11 actor’s former spouse, a person with whom the adult actor has or had a dating
12 relationship, or a person with whom the adult actor”.

- 19 **17.** Page 6, line 15: delete “an adult with whom the person” and substitute “a
20 person with whom the adult”.

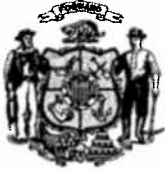

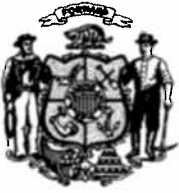

5 fraternization between 2 individuals in a business or social context. A court shall
6 determine if a dating relationship existed by considering the length of the
7 relationship, the type of the relationship, and the frequency of the interaction
8 between the individuals involved in the relationship”.
