2 **1.** Page 5, line 20: delete "has the meaning given in s. 813.12 (1) (ag)" and
3 substitute "means a romantic or intimate social relationship between 2 individuals
4 but "dating relationship" does not include a casual relationship or an ordinary
5 fraternization between 2 individuals in a business or social context. A court shall
6 determine if a dating relationship existed by considering the length of the
7 relationship, the type of the relationship, and the frequency of the interaction
8 between the individuals involved in the relationship".
