By adding "that holds itself out to the public in any way as a legitimate institution of higher education" at page 1, line 5, we are saying right at the outset that s. 38.50 (12) (a) does not apply to a person who *does not* hold itself out as a legitimate institution of higher education. Accordingly, the Mustard Museum exception at page 2, lines 3 to 5, is no longer necessary and can come out.
