AN ACT *to amend* 36.25 (21) (title); and *to create* 36.25 (21) (d) of the statutes;

**relating to:** directing the University of Wisconsin Law School to require students to complete a clinical practicum.

Analysis by the Legislative Reference Bureau

This bill directs the University of Wisconsin Law School to require students to successfully complete a six to eight credit clinical practicum in order to receive a degree. The requirement first applies to students receiving a degree in 2009.

## The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 4 Section 1. 36.25 (21) (title) of the statutes is amended to read:

- 6 **SECTION 2.** 36.25 (21) (d) of the statutes is created to read:
- 7 36.25 **(21)** (d) Require students to successfully complete a 6 to 8 credit clinical
- 8 practicum, in lieu of other courses, in order to receive a degree.
