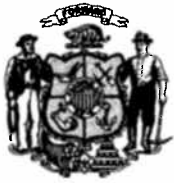

1 At the locations indicated, amend the amendment as follows:

2 1. Page 13, line 14: delete "The" and substitute "Subject to par. (cm), the".

3 2. Page 14, line 3: on lines 3 and 12 delete "The" and substitute "Subject to par.
4 (cm), the".

5 3. Page 14, line 16: after that line insert:

6 "(cm) For a 1st class city, the allocation of a recovery zone bond limitation
7 received by such a city shall be considered waived on August 1, 2010, except with
8 regard to any amount about which the city sends written notice to the department
9 of commerce before that date in which the city states one of the following:

10 Not 1. That recovery zone bonds have been issued pursuant to the city's limitation
11 allocation. // ,

1 2. That an agreement has been executed by the city, county, other local
2 governmental unit, or authority that will issue the recovery zone bonds, and a bond
3 purchaser, providing for the purchase of recovery zone bonds.”
