Hi Chris,

Our office would like to request an amendment to AB 671. We would like to make the following changes:

Page 5 line 14 – change the 3 year maximum for temporary licensure to 18 months

Page 6 line 4 – change the “or obtained active” to “and obtained active” so that an AA would have to both pass the certifying exam and have active certification

Page 9 line 16-18 – we would like to require that anesthesiology resident who has completed his first year of residency must be practicing under the supervision of an anesthesiologist. I think all we would need to do for this one is add “and practicing under the supervision of an anesthesiologist” after the word “residency” on line 18.

Page 10 line 16-22 – Delete the provision that states the UW must conduct a feasibility study

If you have any questions about these changes, please let me know. We would also like to get a copy of this draft as soon as possible as we are looking to exec on this bill next week.
