AN ACT to create 301.50 of the statutes; relating to: notification to a parent

2 before chaperoning a sex offender.

### Analysis by the Legislative Reference Bureau

Currently, the Department of Corrections (DOC) approves individuals as chaperones for sex offenders, and DOC designs a chaperone agreement for the individual to sign. This bill requires the chaperone agreement to indicate that the individual has notified any other person with whom the individual has a child in common of the individual's intention to chaperone a sex offender.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**S**ECTION **1**. 301.50 of the statutes is created to read:

**301.50 Notification of intent to chaperone sex offenders.** The department shall design a form to be signed by any individual who intends to be a chaperone for sex offenders. The form must include a place for the individual's signature as well as a statement that the individual has, unless sub. (1), (2), or (3) applies, informed any individual with whom the individual who intends to be a

| chaperone has a child in common, whether through blood, marriage, or adoption, of     |

- (1) The child in common is over the age of 18.
- **(2)** The individual who intends to be a chaperone is not the child's parent or has failed to assume parental responsibility.
- **(3)** The individual who has a child in common with the individual who intends to be a chaperone is not the child's parent or has failed to assume parental responsibility.

#### **SECTION 2. Initial applicability.**

(1) This act first applies to individuals who are approved to be a chaperone on the effective date of this subsection.
