Analysis by the Legislative Reference Bureau

Article 7 of the Uniform Commercial Code (UCC) regulates the transfer of goods in interstate commerce, specifically dealing with the transfer of title to goods that are

moved or shipped from one location to another. Wisconsin had earlier enacted article 7 of the UCC, but in 2003 the National Conference of Commissioners on Uniform State Laws adopted a revised version of article 7 of the UCC and recommended its enactment in all of the states. This ~~substitute amendment~~ enacts the revised version of article 7 of the UCC into Wisconsin law.

The transfer of goods in interstate commerce involves not only the shipment and storage of tangible goods, but also the transfer of the ownership rights to those goods. Under current law, such rights are transferred by specific documents of title. These title documents are paper documents, consisting of originals and copies, and may be either negotiable or nonnegotiable. The use of paper documents to transfer title and other ownership rights has worked well in the past, but as commercial transactions in the United States and around the world are increasingly conducted and facilitated through electronic means the current-law requirements for paper documents may now impede the transfer of title to goods that are moved or shipped from one location to another. Revised article 7 of the UCC addresses this issue by permitting electronic documents of title for the transfer of goods in interstate commerce.

Under the ~~substitute amendment~~, article 7 of the UCC is revised to provide that a lawful document of title includes an electronic document of title, which is evidenced by a record consisting of information stored in an electronic medium. Under the ~~substitute amendment~~, for the purpose of transferring ownership rights in tangible goods, electronic documents of title are the legal equivalent ^{to} paper documents of title. The remaining portions of current law relating to article 7 of the UCC are amended to facilitate the use of either electronic documents of title or the current paper documents of title. Most importantly, revised article 7 of the UCC, as contained in the ~~substitute amendment~~, creates new definitions of "record" and "sign." Under the ~~substitute amendment~~, a record is "information that is inscribed on a tangible medium or that is stored in an electronic or other medium and is retrievable in perceivable form." The term "sign" is defined to ^{execute or adopt} a tangible symbol" and "to attach or logically associate with the record an electronic sound, symbol, or process." Wherever the term "writing" or an equivalent was previously used in article 7 of the UCC, the term "record" is uniformly used in ^{the} revised article 7 of the UCC. When a document is required to be signed under article 7 of the UCC, electronic signing ^{meets the test} under ^{the} revised article 7 of the UCC.

Finally, the ~~substitute amendment~~ incorporates all technical or nonsubstantive portions of revised article 7 of the UCC that update or clarify the earlier version of article 7 of the UCC, as well as eliminates provisions that no longer have legal effect.

8 **— DOCUMENTS OF TITLE**

9 **SUBCHAPTER I**

10 **GENERAL**

11 **407.101 Short title.** (1) This chapter may be cited as uniform commercial code
12 — documents of title.

13 **407.102 Definitions and index of definitions.** (1) In this chapter, unless
14 the context otherwise requires:

15 (a) “Bailee” means a person that by a warehouse receipt, bill of lading, or other
16 document of title acknowledges possession of goods and contracts to deliver them.

17 (b) “Carrier” means a person that issues a bill of lading.

18 (c) “Consignee” means a person named in a bill of lading to which or to whose
19 order the bill promises delivery.

20 (d) “Consignor” means a person named in a bill of lading as the person from
21 which the goods have been received for shipment.

22 (e) “Delivery order” means a record that contains an order to deliver goods
23 directed to a warehouse, carrier, or other person that in the ordinary course of
24 business issues warehouse receipts or bills of lading.

1 (f) "Good faith" means honesty in fact and the observance of reasonable
2 commercial standards of fair dealing.

3 (g) "Goods" means all things that are treated as movable for the purposes of a
4 contract for storage or transportation.

5 (h) "Issuer" means a bailee that issues a document of title or, in the case of an
6 unaccepted delivery order, the person that orders the possessor of goods to deliver.
7 The term includes a person for which an agent or employee purports to act in issuing
8 a document if the agent or employee has real or apparent authority to issue
9 documents, even if the issuer did not receive any goods, the goods were misdescribed,
10 or in any other respect the agent or employee violated the issuer's instructions.

11 (i) "Person entitled under the document" means the holder, in the case of a
12 negotiable document of title, or the person to which delivery of the goods is to be made
13 by the terms of, or pursuant to instructions in a record under, a nonnegotiable
14 document of title.

15 (j) "Record" means information that is inscribed on a tangible medium or that
16 is stored in an electronic or other medium and is retrievable in perceivable form. ✓

17 (k) "Shipper" means a person that enters into a contract of transportation with
18 a carrier.

19 (L) "Sign" means, with present intent to authenticate or adopt a record, any of
20 the following:

21 1. To execute or adopt a tangible symbol. ✓

22 2. To attach to or logically associate with the record an electronic sound, symbol,
23 or process. ✓

24 (m) "Warehouse" means a person engaged in the business of storing goods for
25 hire.

1 (2) Definitions in other chapters applying to this chapter and the sections in
2 which they appear are:

3 (a) "Contract for sale," s. 402.106. ✓

4 (b) "Lessee in ordinary course of business," s. 411.103. ✓

5 (c) "Receipt" of goods, s. 402.103. ✓

8 **407.103 Relation of chapter to treaty or statute.** (1) This chapter is
9 subject to any treaty or statute of the United States or a regulatory statute of this
10 state to the extent the treaty, statute, or regulatory statute is applicable.

11 (2) This chapter does not repeal or modify any law prescribing the form or
12 contents of a document of title or the services or facilities to be afforded by a bailee,
13 or otherwise regulating a bailee's businesses in respects not specifically treated in
14 this chapter. However, violation of ~~the law~~ ^{such a law} does not affect the status of a document
15 of title that otherwise complies with the definition of a document of title. ✓

16 (3) This chapter modifies, limits, and supersedes the federal Electronic
17 Signatures in Global and National Commerce Act, 15 USC 7001 to 7031, but does not
18 modify, limit, or supersede section 101 (c) of that act, 15 USC 7001(c), or authorize

23 **407.104 Negotiable and nonnegotiable document of title.** (1) Except as
24 provided in sub. (3), a document of title is negotiable if by its terms the goods are to
25 be delivered to bearer or to the order of a named person.

1 (2) A document of title other than one described in sub. (1) is nonnegotiable.
2 A bill of lading that states that the goods are consigned to a named person is not made
3 negotiable by a provision that the goods are to be delivered only against an order in
4 a record signed by the same or another named person.

5 (3) A document of title is nonnegotiable if, at the time it is issued, the document
6 has a conspicuous legend, however expressed, that it is nonnegotiable.

7 **407.105 Reissuance in alternative medium.** (1) Upon request of a person
8 entitled under an electronic document of title, the issuer of the electronic document
9 may issue a tangible document of title as a substitute for the electronic document if
10 all of the following apply:

11 (a) The person entitled under the electronic document surrenders control of the
12 document to the issuer.

13 (b) The tangible document when issued contains a statement that it is issued
14 in substitution for the electronic document.

15 (2) Upon issuance of a tangible document of title in substitution for an
16 electronic document of title in accordance with sub. (1), all of the following apply:

17 (a) The electronic document ceases to have any effect or validity.

18 (b) The person that procured issuance of the tangible document warrants to all
19 subsequent persons entitled under the tangible document that the warrantor was a
20 person entitled under the electronic document when the warrantor surrendered
21 control of the electronic document to the issuer.

22 (3) Upon request of a person entitled under a tangible document of title, the
23 issuer of the tangible document may issue an electronic document of title as a
24 substitute for the tangible document if all of the following apply:

1 (a) The person entitled under the tangible document surrenders possession of
2 the document to the issuer.

3 (b) The electronic document when issued contains a statement that it is issued
4 in substitution for the tangible document.

5 (4) Upon issuance of the electronic document of title in substitution for a
6 tangible document of title in accordance with sub. (3), all of the following apply:

7 (a) The tangible document ceases to have any effect or validity.

8 (b) The person that procured issuance of the electronic document warrants to
9 all subsequent persons entitled under the electronic document that the warrantor
10 was a person entitled under the tangible document when the warrantor surrendered
11 possession of the tangible document to the issuer.

12 **407.106 Control of electronic document of title. (1)** A person has control
13 of an electronic document of title if a system employed for evidencing the transfer of
14 interests in the electronic document reliably establishes that person as the person
15 to which the electronic document was issued or transferred.

16 (2) A system satisfies sub. (1), and a person is deemed to have control of an
17 electronic document of title, if the document is created, stored, and assigned in such
18 a manner that satisfies all of the following:

19 (a) A single authoritative copy of the document exists which is unique, as
20 identifiable, and, except as otherwise provided in pars. (d), (e), and (f), unalterable. *STET: leave as typed*

21 (b) The authoritative copy identifies the person asserting control as one of the
22 following:

23 1. The person to which the document was issued.

24 2. If the authoritative copy indicates that the document has been transferred,
25 the person to which the document was most recently transferred.

1 (c) The authoritative copy is communicated to and maintained by the person
2 asserting control or its designated custodian.

3 (d) Copies or amendments that add or change an identified assignee of the
4 authoritative copy can be made only with the consent of the person asserting control.

5 (e) Each copy of the authoritative copy and any copy of a copy is readily
6 identifiable as a copy that is not the authoritative copy.

7 (f) Any amendment of the authoritative copy is readily identifiable as
8 authorized or unauthorized.

9 SUBCHAPTER II

10 WAREHOUSE RECEIPTS: SPECIAL

11 PROVISIONS

12 **407.201 Person that may issue a warehouse receipt; storage under**
13 **bond. (1)** A warehouse receipt may be issued by any warehouse.

14 (2) If goods, including distilled spirits and agricultural commodities, are stored
15 under a statute requiring a bond against withdrawal or a license for the issuance of
16 receipts in the nature of warehouse receipts, a receipt issued for the goods is deemed
17 to be a warehouse receipt even if issued by a person that is the owner of the goods
18 and is not a warehouse.

19 **407.202 Form of warehouse receipt. (1)** A warehouse receipt need not be
20 in any particular form.

21 (2) Unless a warehouse receipt provides for each of the following, the
22 warehouse is liable for damages caused to a person injured by its omission:

23 (a) The location of the warehouse facility where the goods are stored.

24 (b) The date of issue of the receipt.

25 (c) The unique identification code of the receipt.

1 (d) A statement whether the goods received will be delivered to the bearer, to
2 a named person, or to a named person or its order.

3 (e) The rate of storage and handling charges, but if goods are stored under a
4 field warehousing arrangement, a statement of that fact is sufficient on a
5 nonnegotiable receipt.

6 (f) A description of the goods or the packages containing them.

7 (g) The signature of the warehouse or its agent.

8 (h) If the receipt is issued for goods that the warehouse owns, either solely,
9 jointly, or in common with others, the fact of that ownership.

10 (i) A statement of the amount of advances made and of liabilities incurred for
11 which the warehouse claims a lien or security interest, but if the precise amount of
12 advances made or of liabilities incurred is, at the time of the issue of the receipt,
13 unknown to the warehouse or to its agent that issued the receipt, a statement of the
14 fact that advances have been made or liabilities incurred and the purpose of the
15 advances or liabilities is sufficient.

16 (3) A warehouse may insert in its receipt any terms that are not contrary to chs.
17 401 to 411 and do not impair its obligation of delivery under s. 407.403 or its duty of
18 care under s. 407.204. Any contrary provisions are ineffective.

19 **407.203 Liability for nonreceipt or misdescription.** A party to or
20 purchaser for value in good faith of a document of title, other than a bill of lading,
21 that relies upon the description of the goods in the document may recover from the
22 issuer damages caused by the nonreceipt or misdescription of the goods, except to the
23 extent that any of the following apply:

24 (1) The document conspicuously indicates that the issuer does not know
25 whether all or part of the goods in fact were received or conform to the description,

1 such as a case in which the description is in terms of marks or labels or kind, quantity,
2 or condition, or the receipt or description is qualified by “contents, condition, and
3 quality unknown,” “said to contain,” or words of similar import, if the indication is
4 true.

5 (2) The party or purchaser otherwise has notice of the nonreceipt or
6 misdescription.

7 **407.204 Duty of care; contractual limitation of warehouse’s liability.**

8 (1) A warehouse is liable for damages for loss of or injury to the goods caused by its
9 failure to exercise care with regard to the goods that a reasonably careful person
10 would exercise under similar circumstances. However, unless otherwise agreed, the
11 warehouse is not liable for damages that could not have been avoided by the exercise
12 of that care.

13 (2) Damages may be limited by a term in the warehouse receipt or storage
14 agreement limiting the amount of liability in case of loss or damage beyond which
15 the warehouse is not liable. Such a limitation is not effective with respect to the
16 warehouse’s liability for conversion to its own use. The warehouse’s liability, on
17 request of the bailor in a record at the time of signing such storage agreement or
18 within a reasonable time after receipt of the warehouse receipt, may be increased on
19 part or all of the goods covered by the storage agreement or the warehouse receipt.
20 In this event, increased rates may be charged based on an increased valuation of the
21 goods.

22 (3) Reasonable provisions as to the time and manner of presenting claims and
23 commencing actions based on the bailment may be included in the warehouse receipt
24 or storage agreement.

1 **407.205 Title under warehouse receipt defeated in certain cases.** A
2 buyer in ordinary course of business of fungible goods sold and delivered by a
3 warehouse that is also in the business of buying and selling such goods takes the
4 goods free of any claim under a warehouse receipt even if the receipt is negotiable
5 and has been duly negotiated.

6 **407.206 Termination of storage at warehouse's option. (1)** A warehouse,
7 by giving notice to the person on whose account the goods are held and any other
8 person known to claim an interest in the goods, may require payment of any charges
9 and removal of the goods from the warehouse at the termination of the period of
10 storage fixed by the document of title or, if a period is not fixed, within a stated period
11 not less than 30 days after the warehouse gives notice. If the goods are not removed
12 before the date specified in the notice, the warehouse may sell them pursuant to s.
13 407.210.

14 **(2)** If a warehouse in good faith believes that goods are about to deteriorate or
15 decline in value to less than the amount of its lien within the time provided in sub.
16 (1) and s. 407.210, the warehouse may specify in the notice given under sub. (1) any
17 reasonable shorter time for removal of the goods and, if the goods are not removed,
18 may sell them at public sale held not less than one week after a single advertisement
19 or posting.

20 **(3)** If, as a result of a quality or condition of the goods of which the warehouse
21 did not have notice at the time of deposit, the goods are a hazard to other property,
22 the warehouse facilities, or other persons, the warehouse may sell the goods at public
23 or private sale without advertisement or posting on reasonable notification to all
24 persons known to claim an interest in the goods. If the warehouse, after a reasonable

1 effort, is unable to sell the goods, it may dispose of them in any lawful manner and
2 does not incur liability by reason of that disposition.

3 (4) A warehouse shall deliver the goods to any person entitled to them under
4 this chapter upon due demand made at any time before sale or other disposition
5 under this section.

6 (5) A warehouse may satisfy its lien from the proceeds of any sale or disposition
7 under this section but shall hold the balance for delivery on the demand of any person
8 to which the warehouse would have been bound to deliver the goods.

9 **407.207 Goods must be kept separate; fungible goods.** (1) Unless the
10 warehouse receipt provides otherwise, a warehouse shall keep separate the goods
11 covered by each receipt so as to permit at all times identification and delivery of those
12 goods. However, different lots of fungible goods may be commingled.

13 (2) If different lots of fungible goods are commingled, the goods are owned in
14 common by the persons entitled thereto and the warehouse is severally liable to each
15 owner for that owner's share. If, because of overissue, a mass of fungible goods is
16 insufficient to meet all the receipts the warehouse has issued against it, the persons
17 entitled include all holders to which overissued receipts have been duly negotiated.

18 **407.208 Altered warehouse receipts.** If a blank in a negotiable tangible
19 warehouse receipt has been filled in without authority, a good faith purchaser for
20 value and without notice of the lack of authority may treat the insertion as
21 authorized. Any other unauthorized alteration leaves any tangible or electronic
22 warehouse receipt enforceable against the issuer according to its original tenor.

23 **407.209 Lien of warehouse.** (1) A warehouse has a lien against the bailor
24 on the goods covered by a warehouse receipt or storage agreement or on the proceeds
25 thereof in its possession for charges for storage or transportation, including

1 demurrage and terminal charges, insurance, labor, or other charges, present or
2 future, in relation to the goods, and for expenses necessary for preservation of the
3 goods or reasonably incurred in their sale pursuant to law. If the person on whose
4 account the goods are held is liable for similar charges or expenses in relation to other
5 goods whenever deposited, and it is stated in the warehouse receipt or storage
6 agreement that a lien is claimed for charges and expenses in relation to other goods,
7 the warehouse also has a lien against the goods covered by the warehouse receipt or
8 storage agreement or on the proceeds thereof in its possession for those charges and
9 expenses, whether or not the other goods have been delivered by the warehouse.
10 However, as against a person to which a negotiable warehouse receipt is duly
11 negotiated, a warehouse's lien is limited to charges in an amount or at a rate specified
12 in the warehouse receipt or, if no charges are so specified, to a reasonable charge for
13 storage of the specific goods covered by the receipt subsequent to the date of the
14 receipt.

15 (2) The warehouse may also reserve a security interest under ch. 409 against
16 the bailor for the maximum amount specified on the receipt for charges other than
17 those specified in sub. (1), such as for money advanced and interest. A security
18 interest is governed by ch. 409.

19 (3) A warehouse's lien for charges and expenses under sub. (1) or a security
20 interest under sub. (2) is also effective against any person that so entrusted the bailor
21 with possession of the goods that a pledge of them by the bailor to a good faith
22 purchaser for value would have been valid. However, the lien or security interest is
23 not effective against a person that before issuance of a document of title had a legal
24 interest or a perfected security interest in the goods and that did not do any of the
25 following:

1 (a) Deliver or entrust the goods or any document covering the goods to the bailor
2 or the bailor’s nominee with actual or apparent authority to ship, store, or sell; or
3 with power to obtain delivery under s. 407.403; or with power of disposition under
4 s. 402.403, 409.320, 409.321 (3), 411.304 (2), or 411.305 (2), or other statute or rule
5 of law.

6 (b) Acquiesce in the procurement by the bailor or its nominee of any document.

7 **(4)** A warehouse’s lien on household goods for charges and expenses in relation
8 to the goods under sub. (1) is also effective against all persons if the depositor was
9 the legal possessor of the goods at the time of deposit. In this subsection, “household
10 goods” means furniture, furnishings, or personal effects used by the depositor in a
11 dwelling.

12 **(5)** A warehouse loses its lien on any goods that it voluntarily delivers or
13 unjustifiably refuses to deliver.

14 **407.210 Enforcement of warehouse’s lien. (1)** Except as otherwise
15 provided in sub. (2), a warehouse’s lien may be enforced by public or private sale of
16 the goods, in bulk or in packages, at any time or place and on any terms that are
17 commercially reasonable, after notifying all persons known to claim an interest in
18 the goods. The notification must include a statement of the amount due, the nature
19 of the proposed sale, and the time and place of any public sale. The fact that a better
20 price could have been obtained by a sale at a different time or in a different method
21 from that selected by the warehouse is not of itself sufficient to establish that the sale
22 was not made in a commercially reasonable manner. The warehouse has sold in a
23 commercially reasonable manner if the warehouse sells the goods in the usual
24 manner in any recognized market therefor, sells at the price current in that market
25 at the time of the sale, or has otherwise sold in conformity with commercially

1 reasonable practices among dealers in the type of goods sold. A sale of more goods
2 than apparently necessary to be offered to ensure satisfaction of the obligation is not
3 commercially reasonable, except in cases covered by the preceding sentence.

4 (2) A warehouse's lien on goods, other than goods stored by a merchant in the
5 course of its business, may be enforced only if all of the following requirements are
6 satisfied:

7 (a) All persons known to claim an interest in the goods must be notified.

8 (b) The notification must include an itemized statement of the claim, a
9 description of the goods subject to the lien, a demand for payment within a specified
10 time not less than 10 days after receipt of the notification, and a conspicuous
11 statement that unless the claim is paid within that time the goods will be advertised
12 for sale and sold by auction at a specified time and place.

13 (c) The sale must conform to the terms of the notification.

14 (d) The sale must be held at the nearest suitable place to where the goods are
15 held or stored.

16 (e) After the expiration of the time given in the notification, an advertisement
17 of the sale must be published once a week for 2 weeks consecutively in a newspaper
18 of general circulation where the sale is to be held. The advertisement must include
19 a description of the goods, the name of the person on whose account the goods are
20 being held, and the time and place of the sale. The sale must take place at least 15
21 days after the first publication. If there is no newspaper of general circulation where
22 the sale is to be held, the advertisement must be posted at least 10 days before the
23 sale in not less than 6 conspicuous places in the neighborhood of the proposed sale.

24 (3) Before any sale pursuant to this section, any person claiming a right in the
25 goods may pay the amount necessary to satisfy the lien and the reasonable expenses

1 incurred in complying with this section. In that event, the goods may not be sold but
2 must be retained by the warehouse subject to the terms of the receipt and this
3 chapter.

4 (4) A warehouse may buy at any public sale held pursuant to this section.

5 (5) A purchaser in good faith of goods sold to enforce a warehouse's lien takes
6 the goods free of any rights of persons against which the lien was valid, despite the
7 warehouse's noncompliance with this section.

8 (6) A warehouse may satisfy its lien from the proceeds of any sale pursuant to
9 this section but shall hold the balance, if any, for delivery on demand to any person
10 to which the warehouse would have been bound to deliver the goods.

11 (7) The rights provided by this section are in addition to all other rights allowed
12 by law to a creditor against a debtor.

13 (8) If a lien is on goods stored by a merchant in the course of its business, the
14 lien may be enforced in accordance with sub. (1) or (2).

15 (9) A warehouse is liable for damages caused by failure to comply with the
16 requirements for sale under this section and, in case of willful violation, is liable for
17 conversion.

18 SUBCHAPTER III

19 BILLS OF LADING: SPECIAL

20 PROVISIONS

21 **407.301 Liability for nonreceipt or misdescription; "said to contain";**
22 **"shipper's load and count"; improper handling. (1)** A consignee of a
23 nonnegotiable bill of lading which has given value in good faith, or a holder to which
24 a negotiable bill has been duly negotiated, relying upon the description of the goods
25 in the bill or upon the date shown in the bill, may recover from the issuer damages

1 caused by the misdating of the bill or the nonreceipt or misdescription of the goods,
2 except to the extent that the document of title indicates that the issuer does not know
3 whether any part or all of the goods in fact were received or conform to the
4 description, such as in a case in which the description is in terms of marks or labels
5 or kind, quantity, or condition or the receipt or description is qualified by “contents
6 or condition of contents of packages unknown,” “said to contain,” “shipper’s weight,
7 load, and count,” or words of similar import, if that indication is true.

8 (2) If goods are loaded by the issuer of the bill of lading, the issuer shall count
9 the packages of goods if shipped in packages and ascertain the kind and quantity if
10 shipped in bulk and words such as “shipper’s weight, load, and count,” or words of
11 similar import indicating that the description was made by the shipper are
12 ineffective except as to goods concealed by packages.

13 (3) If bulk goods are loaded by a shipper that makes available to the issuer of
14 the bill of lading adequate facilities for weighing those goods, the issuer shall
15 ascertain the kind and quantity within a reasonable time after receiving the
16 shipper’s request in a record to do so. In that case, “shipper’s weight” or words of
17 similar import are ineffective.

18 (4) The issuer, by including in the bill of lading the words “shipper’s weight,
19 load, and count,” or words of similar import, may indicate that the goods were loaded
20 by the shipper, and, if that statement is true, the issuer is not liable for damages
21 caused by the improper loading. However, omission of such words does not imply
22 liability for damages caused by improper loading.

23 (5) A shipper guarantees to the issuer the accuracy at the time of shipment of
24 the description, marks, labels, number, kind, quantity, condition, and weight, as
25 furnished by the shipper, and the shipper shall indemnify the issuer against damage

1 caused by inaccuracies in those particulars. This right of the issuer to that indemnity
2 does not limit its responsibility or liability under the contract of carriage to any
3 person other than the shipper.

4 **407.302 Through bills of lading and similar documents of title. (1)** The
5 issuer of a through bill of lading or other document of title embodying an undertaking
6 to be performed in part by a person acting as its agent or by a performing carrier is
7 liable to any person entitled to recover on the document for any breach by the other
8 person or the performing carrier of its obligation under the document. However, to
9 the extent that the bill covers an undertaking to be performed overseas or in territory
10 not contiguous to the continental United States or an undertaking including matters
11 other than transportation, this liability for breach by the other person or the
12 performing carrier may be varied by agreement of the parties.

13 **(2)** If goods covered by a through bill of lading or other document of title
14 embodying an undertaking to be performed in part by a person other than the issuer
15 are received by that person, the person is subject, with respect to its own performance
16 while the goods are in its possession, to the obligation of the issuer. The person's
17 obligation is discharged by delivery of the goods to another person pursuant to the
18 document and does not include liability for breach by any other person or by the
19 issuer.

20 **(3)** The issuer of a through bill of lading or other document of title described
21 in sub. (1) is entitled to recover from the performing carrier, or other person in
22 possession of the goods when the breach of the obligation under the document
23 occurred, all of the following:

1 (a) The amount it may be required to pay to any person entitled to recover on
2 the document for the breach, as may be evidenced by any receipt, judgment, or
3 transcript of judgment.

4 (b) The amount of any expense reasonably incurred by the issuer in defending
5 any action commenced by any person entitled to recover on the document for the
6 breach.

7 **407.303 Diversion; reconsignment; change of instructions. (1)** Unless
8 the bill of lading otherwise provides, a carrier may deliver the goods to a person or
9 destination other than that stated in the bill or may otherwise dispose of the goods,
10 without liability for misdelivery, on instructions from any of the following:

11 (a) The holder of a negotiable bill.

12 (b) The consignor on a nonnegotiable bill even if the consignee has given
13 contrary instructions.

14 (c) The consignee on a nonnegotiable bill in the absence of contrary instructions
15 from the consignor, if the goods have arrived at the billed destination or if the
16 consignee is in possession of the tangible bill or in control of the electronic bill.

17 (d) The consignee on a nonnegotiable bill, if the consignee is entitled as against
18 the consignor to dispose of the goods.

19 **(2)** Unless instructions described in sub. (1) are included in a negotiable bill of
20 lading, a person to which the bill is duly negotiated may hold the bailee according to
21 the original terms.

22 **407.304 Tangible bills of lading in a set. (1)** Except as customary in
23 international transportation, a tangible bill of lading may not be issued in a set of
24 parts. The issuer is liable for damages caused by violation of this subsection.

1 (2) If a tangible bill of lading is lawfully issued in a set of parts, each of which
2 contains an identification code and is expressed to be valid only if the goods have not
3 been delivered against any other part, the whole of the parts constitutes one bill.

4 (3) If a tangible negotiable bill of lading is lawfully issued in a set of parts and
5 different parts are negotiated to different persons, the title of the holder to which the
6 first due negotiation is made prevails as to both the document of title and the goods
7 even if any later holder may have received the goods from the carrier in good faith
8 and discharged the carrier's obligation by surrendering its part.

9 (4) A person that negotiates or transfers a single part of a tangible bill of lading
10 issued in a set is liable to holders of that part as if it were the whole set.

11 (5) The bailee is obliged to deliver in accordance with subch. IV[✓] against the first
12 presented part of a tangible bill of lading lawfully issued in a set. Delivery in this
13 manner discharges the bailee's obligation on the whole bill.

14 **407.305 Destination bills.** (1) Instead of issuing a bill of lading to the
15 consignor at the place of shipment, a carrier, at the request of the consignor, may
16 procure the bill to be issued at destination or at any other place designated in the
17 request.

18 (2) Upon request of any person entitled as against a carrier to control the goods
19 while in transit and on surrender of possession or control of any outstanding bill of
20 lading or other receipt covering the goods, the issuer, subject to s. 407.105, may[✓]
21 procure a substitute bill to be issued at any place designated in the request.

22 **407.306 Altered bills of lading.** An unauthorized alteration or filling in of
23 a blank in a bill of lading leaves the bill enforceable according to its original tenor.

24 **407.307 Lien of carrier.** (1) A carrier has a lien on the goods covered by a
25 bill of lading or on the proceeds thereof in its possession for charges after the date

1 of the carrier's receipt of the goods for storage or transportation, including
2 demurrage and terminal charges, and for expenses necessary for preservation of the
3 goods incident to their transportation or reasonably incurred in their sale pursuant
4 to law. However, against a purchaser for value of a negotiable bill of lading, a
5 carrier's lien is limited to charges stated in the bill or the applicable tariffs or, if no
6 charges are stated, a reasonable charge.

7 (2) A lien for charges and expenses under sub. (1) on goods that the carrier was
8 required by law to receive for transportation is effective against the consignor or any
9 person entitled to the goods unless the carrier had notice that the consignor lacked
10 authority to subject the goods to those charges and expenses. Any other lien under
11 sub. (1) is effective against the consignor and any person that permitted the bailor
12 to have control or possession of the goods unless the carrier had notice that the bailor
13 lacked authority.

14 (3) A carrier loses its lien on any goods that it voluntarily delivers or
15 unjustifiably refuses to deliver.

16 **407.308 Enforcement of carrier's lien.** (1) A carrier's lien on goods may
17 be enforced by public or private sale of the goods, in bulk or in packages, at any time
18 or place and on any terms that are commercially reasonable, after notifying all
19 persons known to claim an interest in the goods. The notification must include a
20 statement of the amount due, the nature of the proposed sale, and the time and place
21 of any public sale. The fact that a better price could have been obtained by a sale at
22 a different time or in a different method from that selected by the carrier is not of
23 itself sufficient to establish that the sale was not made in a commercially reasonable
24 manner. The carrier has sold goods in a commercially reasonable manner if the
25 carrier sells the goods in the usual manner in any recognized market therefor, sells

1 at the price current in that market at the time of the sale, or has otherwise sold in
2 conformity with commercially reasonable practices among dealers in the type of
3 goods sold. A sale of more goods than apparently necessary to be offered to ensure
4 satisfaction of the obligation is not commercially reasonable, except in cases covered
5 by the preceding sentence.

6 (2) Before any sale pursuant to this section, any person claiming a right in the
7 goods may pay the amount necessary to satisfy the lien and the reasonable expenses
8 incurred in complying with this section. In that event, the goods may not be sold but
9 must be retained by the carrier, subject to the terms of the bill of lading and this
10 chapter.

11 (3) A carrier may buy at any public sale pursuant to this section.

12 (4) A purchaser in good faith of goods sold to enforce a carrier's lien takes the
13 goods free of any rights of persons against which the lien was valid, despite the
14 carrier's noncompliance with this section.

15 (5) A carrier may satisfy its lien from the proceeds of any sale pursuant to this
16 section but shall hold the balance, if any, for delivery on demand to any person to
17 which the carrier would have been bound to deliver the goods.

18 (6) The rights provided by this section are in addition to all other rights allowed
19 by law to a creditor against a debtor.

20 (7) A carrier's lien may be enforced pursuant to either sub. (1) or the procedure
21 set forth in s. 407.210 (2).

22 (8) A carrier is liable for damages caused by failure to comply with the
23 requirements for sale under this section and, in case of willful violation, is liable for
24 conversion.

407.309 Duty of care; contractual limitation of carrier's liability. (1)

A carrier that issues a bill of lading, whether negotiable or nonnegotiable, shall exercise the degree of care in relation to the goods which a reasonably careful person would exercise under similar circumstances. This subsection does not affect any statute, regulation, or rule of law that imposes liability upon a common carrier for damages not caused by its negligence.

(2) Damages may be limited by a term in the bill of lading or in a transportation agreement that the carrier's liability may not exceed a value stated in the bill or transportation agreement if the carrier's rates are dependent upon value and the consignor is afforded an opportunity to declare a higher value and the consignor is advised of the opportunity. However, such a limitation is not effective with respect to the carrier's liability for conversion to its own use.

(3) Reasonable provisions as to the time and manner of presenting claims and commencing actions based on the shipment may be included in a bill of lading or a transportation agreement.

SUBCHAPTER IV

WAREHOUSE RECEIPTS AND BILLS OF

LADING: GENERAL OBLIGATIONS

407.401 Irregularities in issue of receipt or bill or conduct of issuer.

The obligations imposed by this chapter on an issuer apply to a document of title even if any of the following are satisfied:

(1) The document does not comply with the requirements of this chapter or of any other statute, rule, or regulation regarding its issue, form, or content.

(2) The issuer violated laws regulating the conduct of its business.

1 **(3)** The goods covered by the document were owned by the bailee when the
2 document was issued.

3 **(4)** The person issuing the document is not a warehouse but the document
4 purports to be a warehouse receipt.

5 **407.402 Duplicate document of title; overissue.** A duplicate or any other
6 document of title purporting to cover goods already represented by an outstanding
7 document of the same issuer does not confer any right in the goods, except as
8 provided in the case of tangible bills of lading in a set of parts, overissue of documents
9 for fungible goods, substitutes for lost, stolen, or destroyed documents, or substitute
10 documents issued pursuant to s. 407.105. The issuer is liable for damages caused by
11 its overissue or failure to identify a duplicate document by a conspicuous notation.

12 **407.403 Obligation of warehouse or carrier to deliver; excuse. (1)** A
13 bailee shall deliver the goods to a person entitled under a document of title if the
14 person complies with subs. (2) and (3), unless and to the extent that the bailee
15 establishes any of the following:

16 (a) Delivery of the goods to a person whose receipt was rightful as against the
17 claimant.

18 (b) Damage to or delay, loss, or destruction of the goods for which the bailee is
19 not liable.

20 (c) Previous sale or other disposition of the goods in lawful enforcement of a lien
21 or on a warehouse's lawful termination of storage. ✓

22 (d) The exercise by a seller of its right to stop delivery pursuant to s. 402.705
23 or by a lessor of its right to stop delivery pursuant to s. 411.526. ✓

24 (e) A diversion, reconsignment, or other disposition pursuant to s. 407.303. ✓

1 (f) Release, satisfaction, or any other fact affording a personal defense against
2 the claimant.

3 (g) Any other lawful excuse.

4 (2) A person claiming goods covered by a document of title shall satisfy the
5 bailee's lien if the bailee so requests or the bailee is prohibited by law from delivering
6 the goods until the charges are paid.

7 (3) Unless a person claiming the goods is one against which the document of
8 title does not confer a right under s. 407.503 (1), all of the following apply:

9 (a) The person claiming under a document shall surrender possession or control
10 of any outstanding negotiable document covering the goods for cancellation or
11 indication of partial deliveries.

12 (b) The bailee shall cancel the document or conspicuously indicate in the
13 document the partial delivery or be liable to any person to which the document is duly
14 negotiated.

15 **407.404 No liability for good faith delivery pursuant to document of**
16 **title.** A bailee that in good faith has received goods and delivered or otherwise
17 disposed of the goods according to the terms of a document of title or pursuant to this
18 chapter is not liable for the goods even if any of the following apply:

19 (1) The person from which the bailee received the goods did not have authority
20 to procure the document or to dispose of the goods.

21 (2) The person to which the bailee delivered the goods did not have authority
22 to receive the goods.

23 SUBCHAPTER V

24 WAREHOUSE RECEIPTS AND BILLS OF
25 LADING: NEGOTIATION AND TRANSFER

407.501 Form of negotiation and requirements of due negotiation. (1)

The following rules apply to a negotiable tangible document of title:

(a) If the document's original terms run to the order of a named person, the document is negotiated by the named person's endorsement and delivery. After the named person's endorsement in blank or to bearer, any person may negotiate the document by delivery alone.

(b) If the document's original terms run to bearer, it is negotiated by delivery alone.

(c) If the document's original terms run to the order of a named person and it is delivered to the named person, the effect is the same as if the document had been negotiated.

(d) Negotiation of the document after it has been endorsed to a named person requires endorsement by the named person as well as delivery.

(e) A document is duly negotiated if it is negotiated in the manner stated in this subsection to a holder that purchases it in good faith, without notice of any defense against or claim to it on the part of any person, and for value, unless it is established that the negotiation is not in the regular course of business or financing or involves receiving the document in settlement or payment of a monetary obligation.

(2) The following rules apply to a negotiable electronic document of title:

(a) If the document's original terms run to the order of a named person or to bearer, the document is negotiated by delivery of the document to another person. Endorsement by the named person is not required to negotiate the document.

(b) If the document's original terms run to the order of a named person and the named person has control of the document, the effect is the same as if the document had been negotiated.

1 (c) A document is duly negotiated if it is negotiated in the manner stated in this
2 subsection to a holder that purchases it in good faith, without notice of any defense
3 against or claim to it on the part of any person, and for value, unless it is established
4 that the negotiation is not in the regular course of business or financing or involves
5 taking delivery of the document in settlement or payment of a monetary obligation.

6 (3) Endorsement of a nonnegotiable document of title neither makes it
7 negotiable nor adds to the transferee's rights.

8 (4) The naming in a negotiable bill of lading of a person to be notified of the
9 arrival of the goods does not limit the negotiability of the bill or constitute notice to
10 a purchaser of the bill of any interest of that person in the goods.

11 **407.502 Rights acquired by due negotiation.** (1) Subject to ss. 407.205 ✓
12 and 407.503, a holder to which a negotiable document of title has been duly ✓
13 negotiated acquires thereby all of the following:

14 (a) Title to the document.

15 (b) Title to the goods.

16 (c) All rights accruing under the law of agency or estoppel, including rights to
17 goods delivered to the bailee after the document was issued.

18 (d) The direct obligation of the issuer to hold or deliver the goods according to
19 the terms of the document free of any defense or claim by the issuer except those
20 arising under the terms of the document or under this chapter. In the case of a
21 delivery order, the bailee's obligation accrues only upon the bailee's acceptance of the
22 delivery order and the obligation acquired by the holder is that the issuer and any
23 endorser will procure the acceptance of the bailee.

24 (2) Subject to s. 407.503, title and rights acquired by due negotiation are not
25 defeated by any stoppage of the goods represented by the document of title or by

1 surrender of the goods by the bailee and are not impaired even if any of the following
2 apply:

3 (a) The due negotiation or any prior due negotiation constituted a breach of
4 duty.

5 (b) Any person has been deprived of possession of a negotiable tangible
6 document or control of a negotiable electronic document by misrepresentation, fraud,
7 accident, mistake, duress, loss, theft, or conversion.

8 (c) A previous sale or other transfer of the goods or document has been made
9 to a 3rd person.

10 **407.503 Document of title to goods defeated in certain cases.** (1) A
11 document of title confers no right in goods against a person that before issuance of
12 the document had a legal interest or a perfected security interest in the goods and
13 that did not do any of the following:

14 (a) Deliver or entrust the goods or any document covering the goods to the bailor
15 or the bailor's nominee with actual or apparent authority to ship, store, or sell; with
16 power to obtain delivery under s. 407.403; or with power of disposition under s.
17 402.403, 409.320, 409.321 (3), 411.304 (2), or 411.305 (2), or other statute or rule of
18 law.

19 (b) Acquiesce in the procurement by the bailor or its nominee of any document.

20 (2) Title to goods based upon an unaccepted delivery order is subject to the
21 rights of any person to which a negotiable warehouse receipt or bill of lading covering
22 the goods has been duly negotiated. That title may be defeated under s. 407.504 to
23 the same extent as the rights of the issuer or a transferee from the issuer.

24 (3) Title to goods based upon a bill of lading issued to a freight forwarder is
25 subject to the rights of any person to which a bill issued by the freight forwarder is

1 duly negotiated. However, delivery by the carrier in accordance with subch. IV
2 pursuant to its own bill of lading discharges the carrier's obligation to deliver.

3 **407.504 Rights acquired in absence of due negotiation; effect of**
4 **diversion; stoppage of delivery. (1)** A transferee of a document of title, whether
5 negotiable or nonnegotiable, to which the document has been delivered but not duly
6 negotiated, acquires the title and rights that its transferor had or had actual
7 authority to convey.

8 **(2)** In the case of a nonnegotiable document of title, until but not after the bailee
9 receives notice of the transfer, the rights of the transferee may be defeated by any of
10 the following:

11 (a) Those creditors of the transferor that could treat the transfer as void under



This is a redraft of ASA1 to 2007 AB-481. Note that 2007 AB-481 was based on the draft UCC Article 7 (draft Article 7) that was prepared by the National Conference of Commissioners on Uniform State Laws (NCCUSL) for its meeting in August 2003. After that meeting, NCCUSL made technical changes to the draft that were not incorporated into 2007 AB-481. However, based on a review by the State Bar's Business Law Section, the technical changes were incorporated into ASA1 to 2007 AB-481. I have included copies of both draft Article 7 and the letter describing the State Bar's review in the drafting file for this bill.

Please note the following differences between this redraft and ASA1 to 2007 AB-481:

1. I made changes to the amendment of the definition of "transferable record" in s. 137.24 (1) to fix a grammatical error.
2. I amended s. 799.45 (3) (b) to refer to a "warehouse under s. 407.209," rather than a "warehouse keeper." This change is consistent with other changes made in 2007 AB-481.
