500N (i.3.4)

At the locations indicated, amend the bill as follows:

1. Page 8, line : after that line insert:

"(9m) TERMINATION OF PLAN. The plan under this section shall terminate on the first day of the 25th month beginning after the effective date of this subsection .... [LRB inserts date]. The department shall not pay any claim under this section for services provided after the last day of the 24th month beginning after the effective date of this subsection .... [LRB inserts date], to an individual with coverage under the plan under this section.".
