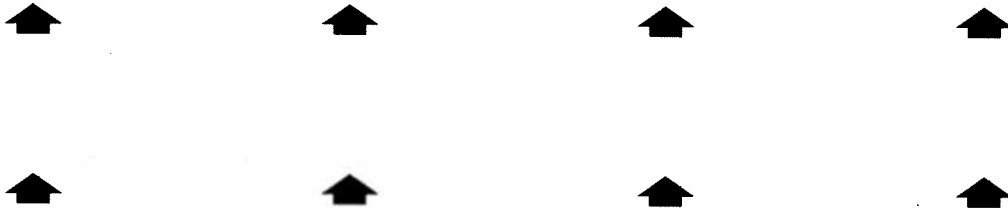

Aaron,

Rep. Roth would like to draft an amendment to Assembly Bill 734 (LRB-3326/1) which is before the Assembly tomorrow morning.

He would like the amendment to include the following three provisions:

1. limit the sales and use tax for the Fox Cities RTA to 0.1%, as opposed to the up to 0.5% called for under the bill.
2. eliminate the ability of the Fox Cities RTA to exercise the power of eminent domain.
3. only grant the Fox Cities RTA authority to collect sales taxes AFTER federal transit aids for operational costs have ended (federal aid for capital expenditures will continue regardless of whether there is a bill or not, but aids for operational costs will terminate following the completion of the federal 2010 census).

I know this is little time to put together an amendment for Tuesday morning, but this is Rep. Roth's request.
