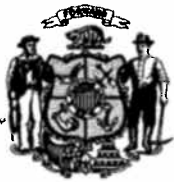

6 66.1039 (4) (t) Notwithstanding any other provision of law, an authority  
7 created under sub. (2) (d) may be funded from rail development bonds and federal  
8 aid previously allocated for high-speed rail passenger service between the cities of  
9 Milwaukee and Madison."
