Assumptions Used in Arriving at Fiscal Estimate

Senate Bill 525 requires each institution to provide information about financial literacy to its students on its Internet Web site and, if the institution offers an on-campus orientation program to new students, to provide the information to students during the orientation. Also, the bill requires an institution's students to complete an online tutorial on financial literacy. The bill does so by prohibiting an institution from allowing an enrolled student to enroll in a subsequent semester, quarter, or term unless the student completes the tutorial.

The web site project will require instructional design, programming, and graphic artist, and media designer time.

50% ISD
10% Graphic Design
20% Programmer time
20% Media design (might be same as ISD)
10% Project Management

The 16 week project would have a fiscal impact of approximately \$65,000.

Long-Range Fiscal Implications

There will be additional costs to monitor completion of this tutorial at each campus. These costs are indeterminate.
