Could you prepare a simple amendment to the sub introduced to AB 782 and Senate Bill 542 using the suggestion provided by David Lovell?

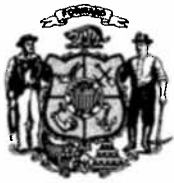
Here is what David suggests:
