5 632.895 (12m) (b) 3. A social worker, as defined in s. 252.15 (1) (er), a marriage
6 and family therapist, as defined in s. 457.01 (3), or a professional counselor, as
7 defined in s. 457.01 (7), who is certified or licensed to practice psychotherapy, as
8 defined in s. 457.01 (8m).".
