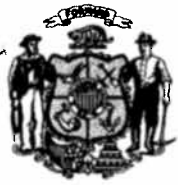

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 32, line 16: delete "or 20.932".

3 **2.** Page 32, line 18: after "barred." insert "An action or claim under s. 20.932
4 shall be commenced within 3 years after the cause of the action or claim accrues or
5 be barred.".
