



If, in addition to the statement of disability, the veteran provides a statement from the U.S. department of veterans affairs certifying to the department that the veteran has been awarded the Purple Heart medal, the department shall issue and deliver to the veteran a plate of special design meeting all of the requirements of this subsection and incorporating a symbol associated with the Purple Heart meda No charge in addition to the registration fee shall be made for the issuance or renewal of such plates under this subsection.

SECTION 2. Effective date.

(1) This act takes effect on the first day of the 7th month beginning after publication.
