- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 19: delete the material beginning with "The" and ending with
- 3 "sub. (2m)." on line 22.
- 4 **2.** Page 4, line 4: after "wetland." insert "The department may not provide a
- 5 wetland confirmation under this paragraph before the earlier of the following:".
- 6 **3.** Page 4, line 4: after that line insert:
- 7 "1. The date on which the department enters into a memorandum of agreement
- 8 with the U.S. Army Corps of Engineers as specified in sub. (2m).
- 9 2. The first day of the 13th month beginning after the effective date of this
- 10 subdivision [LRB inserts date]."
- 11 **4.** Page 4, line 7: delete lines 7 and 8 and substitute "of Engineers will concur
- 12 with any wetland confirmation provided by the department under sub. (2) (c)."
- 13 **5.** Page 7, line 15: delete "county" and substitute "town".
