- At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 19: delete the material beginning with "The" and ending with "sub. (2m)." on line 22.
  - **2.** Page 4, line 4: after "wetland." insert "The department may not provide a wetland confirmation under this paragraph before the earlier of the following:".
    - **3.** Page 4, line 4: after that line insert:
  - "1. The date on which the department enters into a memorandum of agreement with the U.S. Army Corps of Engineers as specified in sub. (2m).
  - 2. The first day of the 13th month beginning after the effective date of this subdivision .... [LRB inserts date].".
- 11 **4.** Page 4, line 7: delete lines 7 and 8 and substitute "of Engineers will concur with any wetland confirmation provided by the department under sub. (2) (c).".
  - **5.** Page 7, line 15: delete "county" and substitute "town".

- **6.** Page 8, line 19: delete "county" and substitute "village".
- **7.** Page 9, line 23: delete "county" and substitute "city".
